Website Privacy Policy

Place Fab ("Company" or "We") welcomes you and is committed to respecting your privacy rights and personal information.

Please read our Privacy Policy carefully to understand our treatment of personal information you provide by visiting and interacting with the PlaceFab.com ("Website"). If you do not agree with our policies and practices, please discontinue use of our Website. By continuing use of this Website, you agree to this privacy policy, which may be updated from time to time. Your continued use after we make such changes will be deemed acceptance of those changes, so it is important to check this page for updates.

This policy describes the types of information the Company may collect from you or that you may provide when you visit our Website, including our practices for collecting and disclosing that information. Information We Collect About You

We collect the following information from users of our Website:

- Your name, phone number, email address, and postal address ("personal information") if
 you purchase a product. We rely on secure third-party vendors to process payment
 information (credit card information) and do not store payment information internally. We
 only work with secure vendors for payment processing services.
- About your Internet connection, the equipment you use to access our Website, and usage details.

We collect this information:

• Directly from you when you submit it.

Automatically as you interact with the site. Information collected automatically may include
usage details, referring URL, web browser type, IP addresses, and information collected
through cookies. We may use Google Analytics to collect this information in order to
analyze and improve the user experience.

Information You Provide to Us

The information we collect on or through our Website may include:

- Information that you provide by filling in forms on our Website. This includes information provided at the time of subscribing to our newsletter or time of product purchase.
- Records and copies of your correspondence (including email addresses), if you contact us.
- Your responses to surveys.
- Your searches on the Website.

You also may provide information to be published or displayed ("User Submissions") on public areas of the Website including the product review section for each product listing. Remember that your User Submissions are posted on and transmitted to others at your own risk, and while comments are moderated, we are not responsible for the actions of others on the Website with whom you may choose to share your User Submissions.

Information We Collect Through Automatic Data Collection Technologies

Throughout your use of our Website, we may use automatic data collection technologies to collect information about the details of your visits, including location data and traffic patterns, internet connection, operating system, and browser/equipment used.

The information we collect automatically does not include personal information, but we may maintain it or associate it with personal information we collect in other ways. This collection helps us improve our Website, services we provide, and allows us to understand our audience's interests and preferences and recognize users when they return to our Website.

Use of Cookies and Pixels

Our Website uses browser cookies to help us improve and provide a better experience for our users. You may adjust your browser setting to refuse to accept browser cookies. Unless you have adjusted your browser setting so that it will refuse cookies, our system will issue cookies when you direct your browser to our Website.

Our Website also features small electronic files known as web beacons (also referred to as pixel tags, and single-pixel gifs that permit the Company, for example, to count users who have visited those pages or and for other related website statistics.

Third-Party Use of Cookies

Some advertisement content on the Website is served by third parties, including advertising networks, business partners, content providers, and application providers. Such third parties may use cookies to collect information about you when you use our website, which may be associated with your personal information and online activities over time and across various websites. This collected information may be used to provide behavioral advertising or other targeted content for you. This

How Your Information Will Be Used

We use information that we collect about you or that you provide to us, including any personal information:

- To complete any obligations you've entered into with our company, and to provide you with information, communications, or products you've requested from us.
- To improve our customer service by responding to your requests for information and products more quickly and efficiently.
- To notify you about changes to our Website or any products or services we offer or provide through it.
- To send you information you agreed to receive about topics we think will be of interest and other periodic emails.
- To run a promotion, contest, or survey.
- To allow you to participate in interactive features on our Website.
- To measure interest and improve our Website and personalize its contents to you.
- For any other purpose with your consent.

We do not share personal information with third parties for direct marketing purposes other than as described in this policy. If our practices change, we will update this policy and provide you with the relevant updates as required by law.

Disclosure of Your Information

We may disclose aggregated information about our users without restriction. We may disclose personal information that we collect or you provide as described in this privacy policy:

- To our subsidiaries and affiliates.
- To contractors, service providers, and other third parties we use to support our business, including secure payment processors.
- To a buyer or other successor of Place Fab in connection with a corporate transaction.
- For any other purpose disclosed by us when you provide the information.

We may also disclose your personal information:

- To comply with any mandated governmental request or court order.
- To enforce or apply our terms of use or terms of sale and other agreements.
- If we believe disclosure is necessary or appropriate to protect the rights, property, or safety of Place Fab and our customers.

Choices About How We Use and Disclose Your Information

We strive to provide you with choices regarding the personal information you provide to us. We have created mechanisms to provide you with the following control over your information:

- Tracking Technologies and Advertising. You can set your browser to refuse all or some browser cookies, or to alert you when cookies are being sent. If you disable or refuse cookies, please note that functionality and access with some parts of this site may be diminished.
- Promotional Offers from the Company.
